



## **GUEST CONSENT AND RISK DISCLOSURE FORM**

**Forgotten World Adventures require that all guests kindly complete and sign this form ahead of their experience with us please. Children aged 15 or under do not require their own form but a legal guardian travelling with the child must sign this form on their behalf.**

### **Understanding the Risks**

I accept that these activities inherently involve risks and potential hazards. The risks and hazards include, but are not limited to, derailment of the rail cart, collision between rail carts or other vehicles, crushing between rail carts, fire, road crossings, extreme weather events, collision or grounding of the jet boat, hitting obstacles (such as rocks or trees), helicopter crash, sunburn/damage and hypothermia.

I am aware that participating in the rail cart and jet boat activities offered by Forgotten World Adventures Limited (FWA) can be hazardous if they are not conducted with care, control and responsibility. I acknowledge that these risks could result in my injury (physical or mental) or even death.

### **Medication and Health Conditions**

- I have informed the staff of FWA, or will prior to undertaking the activities, of any medical conditions, previous injuries and any current medication which may affect my ability to undertake the activities. I confirm I am physically fit and able to participate in the activities and I have not been advised otherwise by a qualified medical person.
- I consent to receive any medical treatment that may be deemed necessary by FWA in the event of injury, accident or illness while undertaking the activities.
- I understand it is my responsibility to disclose any conditions (health or otherwise) that may affect the safety and enjoyment of myself and those around me.

### **Conditions of Participating in Activity**

- I agree to participate with care, and obey the rules set out by FWA and adhere to the instructions given by the guide (or a representative of FWA), at all times.
- I accept that if I do not adhere to the instructions and rules, or if I act dangerously, recklessly or in a way that might endanger myself or others, FWA may remove me from the activities. If this occurs, I acknowledge I will not receive a refund.
- I accept that FWA reserves the right to cancel the activities if it becomes concerned for my safety, or the safety of another person.
- I agree to wear appropriate clothing and use/wear all safety clothing and equipment (as required by the guide or a representative of FWA) at all times when participating.

### **Limited Liability of Forgotten World Adventures**

- I understand that if I act recklessly or intentionally, and don't follow the rules or instructions set out by FWA and the guide, which I have been made aware of, FWA will not be held responsible for any injury, damage or loss I cause to myself/my property, or another person/their property, resulting from my action (or lack of action).

### **Drugs / Alcohol**

- I confirm I am not/ will not be under the influence of intoxicating alcohol or drugs (be they legal or illegal) which may in any way impair my ability to undertake the activities.

### **All Rail Cart Drivers must hold a Full or Restricted Driver Licence (delete if not applicable)**

- I confirm that I hold a valid New Zealand (or international equivalent) Full or Restricted Driver Licence.

### **Consent for Use of Images**

- I give consent for FWA to use or publish any images of me that may be taken during these activities.
